The National Aviation System

The Economic Impact of Civil Aviation on the U.S. Economy (December 2009)

- \$1.3 Trillion in Economic Activity
- \$396 Billion in Earnings
- \$12.0 Million in Jobs
- 5.6% of Gross Domestic Product

This includes commercial service airports, general aviation airports, civil aircraft manufacturing and construction, trade and real estate.

Economic Impacts of Airports in Maine

- Commercial service airports enplane over
 1.0 million passengers
- General aviation brings over 130,000 visitors to Maine each year
- Supports more than 20,900 jobs
- Total of \$487.6 million in payroll
- Generate \$1.5 billion in economic activity
- Total economic impact comprises 3.3% of Maine's estimated Gross State Product

Economic Impacts of Airports in Maine (continued)

- Knox County Regional Airport
 - Supports 362 jobs
 - Total payroll of \$9.2 million
 - \$25.6 million is generated in economic activity
- Belfast Municipal Airport
 - Supports 62 jobs
 - Total payroll of \$1.6 million
 - \$3.9 million is generated in economic activity

- Accessibility

Airport Roles

36 publicly—owned airports are assigned to 1 of 4 roles based on the following criteria:

- Accessibility
- Support of Tourism
- Economic Contribution
- Current Demand
- Historic Investment
- Geographic Coverage

Aircraft Design Group	B or C category aircraft
Primary Runway	At least 5,000 feet long x 100 feet wide
Taxiway	Full parallel
Approach	Precision or precision capabilities
Lighting	High intensity runway, medium intensity taxiway
Visual Aids	Rotating beacon, segmented circle, lighted wind cone, R/W end identifier lights, PAPI
Weather Reporting	On-site weather reporting system (AWOS/ASOS)
Based Aircraft Parking	75% in covered storage, 25% apron parking
Transient Aircraft Parking	25% of overnight aircraft in covered storage, 50% accommodated on apron
GA Auto Parking	Equal to number of based aircraft
Fuel	100LL and Jet A
Terminal	2,000 sq. ft. terminal with phone, restrooms, pilot lounge, flight planning
Aircraft Maintenance	Aircraft repair, avionics
FBO	Full service
Food	Full service restaurant
Ground Transportation	On-site rental car
Security	Full perimeter fencing, controlled access, night guard
Airport Maintenance	Designated building, snow removal equipment, de-icing capabilities

Aircraft Design Group	B or A category aircraft
Primary Runway	2,500 - 3,500 feet long x 60 feet wide
Taxiway	Turnaround
Approach	Visual
Lighting	Low intensity runway, taxiway reflectors
Visual Aids	Segmented circle, lighted wind cone
Based Aircraft Parking	50% in covered storage, 50% apron parking
Transient Aircraft Parking	25% accommodated on apron
GA Auto Parking	Equal to number of 50% based aircraft
Fuel	100LL
Terminal	500 sq. ft. terminal with phone, restrooms
FBO	Limited service
Food	Vending
Security	Full perimeter fencing
